ACKNOWLEDGEMENTS: By signing this agreement Client acknowledges, agrees, and understands that Zoot Pets has not represented, promised, guaranteed, or warranted that Dog can be trained, that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the training will last for any particular amount of time as each dog is different in regards to ability, breeding, and temperament. Client further acknowledges, agrees, and understands that they must practice with Dog in between appointments/classes what they have learned during each lesson and that follow-up and scheduling of future training sessions is their sole responsibility.

POLICIES: _____ (client's initials) My initials indicate that I understand and agree that Zoot Pets does not offer free evaluations or consultations and that the first visit is considered the first lesson of any program or class. I agree and understand that a "no-show" for a scheduled appointment will be counted as a lesson if a refund is requested. I further understand and agree that a program may include admission to classes only when program is paid for in full and that classes have no cash-out value. I understand and agree that lesson duration is determined by the trainer at the time of service and that time spent during appointments discussing my dog, dog training, and/or behavior is considered training/lesson time. I understand and agree that I must practice with my dog in-between appointments in order to get the most benefit and success from any training program. I understand and agree that Zoot Pets does not guarantee any group or specialty class will always be held or take place at any specific location. I further understand and agree that if my dog is aggressive it can be prohibited from attending Zoot Pets's group classes.

Fee is \$500 (\$400 for each additional dog); boarding rates still apply

Play and Train:

Full Package: _____ 14 sessions of daycare with training; dogs are to attend twice per week.
Fee is \$770 (\$670 for each additional dog)

Mini Package: _____ 5 sessions of daycare with training; dogs are to attend as needed/scheduled.
Fee is \$300 per dog

Individual Session: _____ 1 session of daycare with training.
Fee is \$68 per dog

Training Refresher:

Ten Session Package: _____ 10 sessions of training that can be added to boarding.
Fee is \$300 per dog

Five Session Package: _____ 5 sessions of training that can be added to boarding.
Fee is \$165 per dog

Individual Session: _____ 1 session of training that can be added to boarding.
Fee is \$35 per dog

TERMINATION: _____(client's initials) Zoot Pets's services shall terminate if (a) in Zoot Pets's judgment Dog is dangerous or vicious to Zoot Pets or any other person or animal, or interferes with the training of other dogs, (b) Client breaches any term or condition of this Agreement, or (c) Client requests service termination.

HOLD HARMLESS: The client will hold Zoot Pets's owner(s), employee(s), and agent(s) free and harmless from any and all claims, liabilities, damages, losses, or expenses arising out of any injury to any person or to any person's property by the Dog(s) named in this contract while in the care, custody, and control of Zoot Pets' owner(s), employee(s), or agent(s).

LIMITATIONS AND LIABILITIES: Client acknowledges, understands, and agrees that the elimination or modification of behaviors is not guaranteed. Client acknowledges, understands, and agrees that dog training will not provide exact results and that failure to follow the professional advice given to them by Zoot Pets may result in an escalation of behavior and/or training issues. Client further agrees to accept responsibility for any damages the above named Dog(s) may cause through malicious, aggressive, or improper behavior that may occur before, during, or after all services provided by Zoot Pets. Furthermore, Client understands and agrees that if their Dog(s) is injured in a dog fight or an accident, gets fleas, ticks, or intestinal parasites, contracts any illness or disease, is lost or stolen, becomes pregnant, or engages in any dangerous, vicious, or unwanted behavior during or after all services provided by Zoot Pets, on or off Zoot Pets's premises, Client's home or business, or any other location, Client accepts the risk and agrees that Zoot Pets shall not be held responsible for it or any resulting injuries, losses, damages, costs, or expenses.

SOLE AGREEMENT: This Agreement supersedes all prior discussions, representations, warranties, and agreements of the parties, and expresses the entire agreement between Client and Zoot Pets regarding the matters as described on Pages 1 of 2 and 2 of 2. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations, or oral understandings have been made with regard to the Dog(s) or anything else.

CLIENT SIGNATURE: I have read, acknowledge, and agree to all terms, conditions, and legal provisions as set forth on Pages 1 of 2 and 2 of 2 which represent my entire agreement with Zoot Pets.
